This Agreement is entered into by and between Waggin' Tails Doggy Daycare & Hotel ("Waggin' Tails") and _____ ("Owner"):

1. Owner understands and agrees that Owner is solely responsible for any harm caused by Owner's dog(s) while Owner's dog(s) is/are attending Waggin' Tails Doggy Daycare & Hotel. _____ (initials)
2. Owner understands and agrees that during normal dog play, Owner's dog may sustain injuries. All dog play is carefully monitored by Waggin' Tails to avoid injury, but scratches, torn ligaments, etc. may occur despite the best supervision. _____ (initials)
3. Owner further understands and agrees that in admitting Owner's dog(s) to Waggin' Tails Doggy Daycare & Hotel, Waggin' Tails has relied on Owner's representations that Owner's dog(s) is/are in good health and are free of any communicable disease and have not harmed, shown aggression, or exhibited any threatening behavior towards any person or other dog. _____ (initials)
4. Owner further understands and agrees that neither Waggin' Tails nor any of its employees, staff, or volunteers will be liable for any illness, injury, death, and/or escape of Owner's dog(s) provided that reasonable care and precautions are followed, the Owner hereby releases all of them of any liability of any kind whatsoever arising from or as a result of Owner's dog(s) attending or participating at Waggin' Tails Doggy Daycare & Hotel. _____ (initials)
5. Owner further understands and agrees that any behavioral or health problems that develop with the Owner's dog(s) while at Waggin' Tails will be handled and treated as deemed best by the employees, staff, and volunteers of Waggin' Tails, in their sole discretion, and Owner expressly agrees to assume full financial responsibility for any and all expenses arising or relating thereto. This includes aggressive or destructive behavior. _____ (initials)

6. Owner further understands and agrees that Owner's dog(s) will at all times while attending Waggin' Tails have current vaccination status. Owner further understands that even in Owner's dog(s) is vaccinated for Bordatella (Canine Cough) there is a chance that the Owner's dog(s) can still contract Canine Cough. I agree that I will NOT hold Waggin' Tails responsible if Owner's dog(s) contracts Canine Cough.

7. Owner further understands and agrees that Waggin' tails reserves the right to use a bark control device or gentle leader if Owner's dog(s) create a disturbance to the neighborhood. _____ (initials)

Owner further understands and expressly agrees that each and every of the foregoing provisions containing Paragraphs 1 - 8 above shall be in force and effect and shall apply to each and every occasion on which Owner boards or deposits Owner's dog(s) or pet(s) with Waggin' Tails for daycare, hotel or grooming, as the case may be; and that this Agreement shall remain in full force and effect as between the parties until and unless otherwise cancelled or superseded by a writing signed by the parties. _____ (initials)
